
Al-Anon's Tradition Seven

BC/YUKON AREA Financial Report Summary

Contributions lower than pre-covid:

- Groups are transitioning back to in person, some have lower attendance and higher rents
- A number of groups have increased their contributions recently to help with AWSCM costs
- Newer electronic groups do not appear to be contributing yet

Expenses lower than budgeted:

- Some expenses are higher, (ie: hotel rates and meals) but attendance at Area meetings is not at pre-Covid levels making overall expenses less than anticipated
- With new service provider, expenses to maintain website are expected to remain about the same and perhaps a little lower
